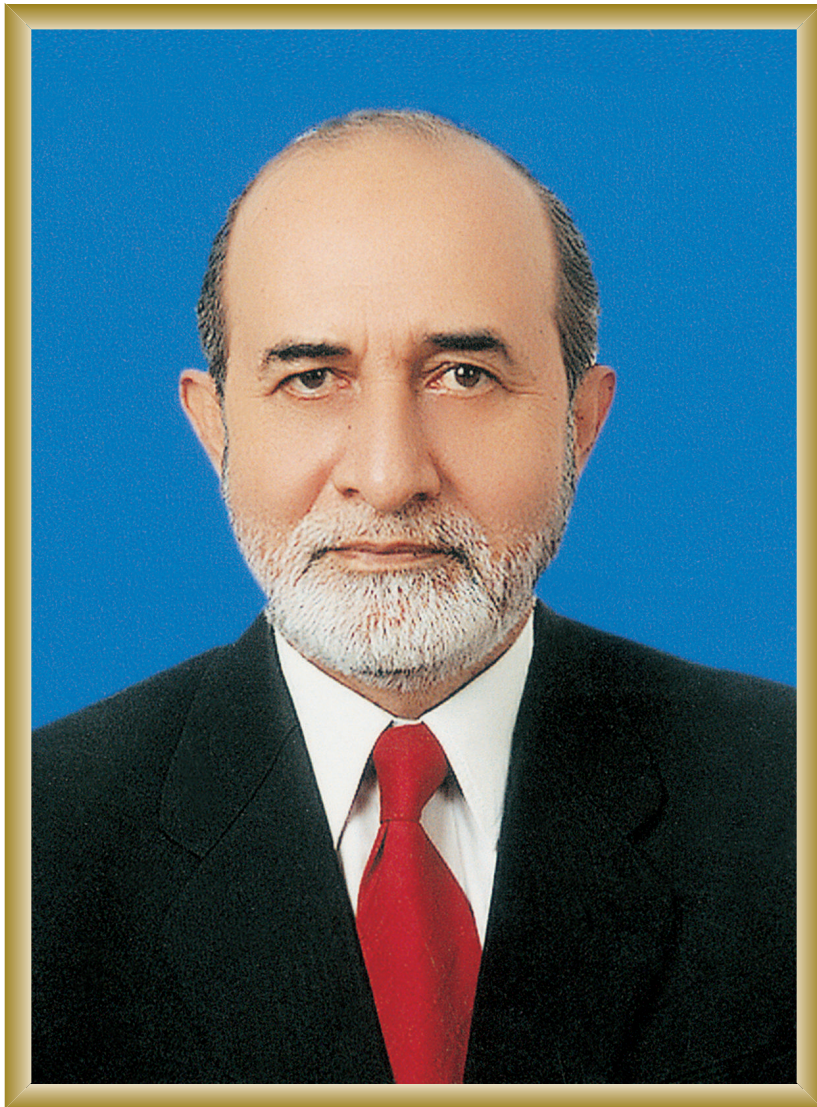

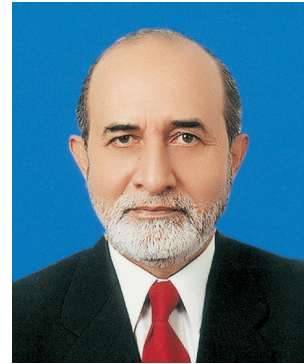

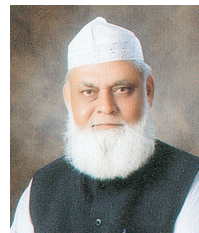

ANNUAL GENERAL BODY MEETING
